1. PURPOSE

1.1 This policy provides information regarding Stanley College's English language proficiency requirements for admission to Bachelor degree courses.

2. SCOPE

2.1 This policy applies to all students of Stanley College, as well as staff involved in the assessment of English language capability.

3. **DEFINITIONS**

Australian Qualifications Framework (AQF)	The AQF is the national policy for regulated qualifications in Australian education and training in Australia. It comprises different qualification levels.
AQF 7	AQF level ascribed to regulated Bachelor degree courses.
Cambridge English (CAE)	Cambridge English: Advanced (CAE), also known as the Certificate in Advanced English (CAE), is an international English language examination developed by Cambridge English Language Assessment (previously known as University of Cambridge ESOL Examinations).
English Language Proficiency	The ability of students to use the English language to make and communicate meaning appropriately in spoken and written forms in the context of their studies.
International English Language Testing System (IELTS)	International English Language Testing System (IELTS) is an international standardised test of English language proficiency. It is jointly managed by University of Cambridge ESOL Examinations, the British Council and IDP Education Pty Ltd.
Pearson Test of English Academic	PTE Academic is a computer-based academic English language test aimed at non-native English speakers wanting to study abroad. It tests Reading, Writing, Listening and Speaking.
Special Tertiary Admissions Test (STAT) – Written English and Multiple Choice	The Special Tertiary Admissions Test (STAT) has been developed by the Australian Council of Educational Research (ACER) to assess competencies commonly considered important for success in tertiary study. There are two tests – the multiple-choice test and the written English test.
Test of English as a Foreign Language (TOEFL)	Test of English as a Foreign Language (TOEFL) is a standardized test to measure the English language ability of non-native speakers wishing to enrol in English-speaking universities.

4. POLICY PROVISIONS

Principles

- 4.1 English language proficiency standards for entry into higher education courses at Stanley College are:
 - a. Clearly indicated in Stanley College's marketing material, course admission information and on the College website;
 - b. At a standard as expected of a course set at AQF level 7; and
 - c. Are benchmarked against other higher education institutions offering a similar course.
- 4.2 All students, whether domestic or international, must provide evidence that their English language ability meets the minimum requirements for admission to a course.
- 4.3 Stanley College reserves the right to request that a student undergoes an English test in addition to any other evidence of English proficiency provided.
- 4.4 Stanley College will require that a student who fails an English test attend Academic and English Support sessions.

Requirements

- 4.5 To be eligible for admission to a higher education course at Stanley College, students must provide at least one form of evidence of English language proficiency from the list below:
 - a. An English Language pass level in an Australian Senior Certificate of Education (Year 12) or equivalent; or
 - b. Satisfactory completion of an accredited Australian qualification equivalent to AQF Level 5 or above; or
 - c. Satisfactory completion of an accredited tertiary award in English; or
 - d. Attainment of a specified level of achievement in an approved English language test as listed in 4.5, below.
- 4.6 The minimum standards of achievement in English language tests approved for higher education study at Stanley College are:

Approved Test	Required score
Cambridge English: Advanced (CAE)	Total score of 169
IELTS (Academic)	IELTS Score of 6.0 (with no individual band score less than 5.5)
TOEFL Internet	Overall score of 60-78 (Section score no less than: Listening 12, Speaking 18, Reading 13, Writing 21)
Pearson Test of English Academic (PTE)	Overall score of 51-55 (no section score less than 46)
Special Tertiary Admissions Test (STAT) - Written English & Multiple Choice	A minimum score of 135 for the STAT Multiple Choice component and a minimum score of 140 for the STAT Written English component

- 4.7 Where students use the *Alternate Entry* or *Work and Life Experience Entry* into a Stanley College higher education course, additional evidence of English capability relevant to the course may be sought. See the Stanley College *Admissions Information Sets* for further details.
- 4.8 Where a student is required to provide a statement or certificate to demonstrate English language proficiency, the documentation must:
 - a. Be a certified copy; and
 - b. Be accompanied by a certified translation if the qualification is not in English.
- 4.8 Where a student has attempted multiple sittings of approved tests, only test results from the **most recent** sitting will be accepted for each application.

Conditional Offers

- 4.9 Stanley College reserves the right to make any offer conditional on meeting English language requirements if the student fails to demonstrate their English language ability is sufficient.
- 4.10 This conditional offer means that the student is not permitted to be accepted in the course until English language proficiency is reassessed once further evidence of proficiency has been provided by the student.
- 4.11 A full offer will only be issued once English language proficiency requirements have been met.
